NNDC case officer: Natalie Levett. Councillors welcome the chance of improving this run-down section of Oak Street however the Council objects to the application as they feel it should be two dwellings rather than three. The Council would also ask that when the application is granted they would like to see a Traffic Management Plan. PA 4460 (PF/21/0799) – Change of use of upper floors over shops to form three flats including demolition and alterations to rear elevation - 6-8 & 10 Norwich Street, NR21 9AE. NNDC case officer: Jayne Owen. Councillors offered no objection and no comment.

Revised plans have been received. The original application was considered at the D & M meeting 15th February 2021 where Councillors offered no objection or comment.</p> <p>Councillors supported the application.</p> <p>PA 4461 (PF/21/0868) - Erection of five dwellings - 31 Greenway Lane, NR21 8DF.
